## AGM BYLAWS \& VOTING RIGHTS

## Article IX: Districts

## Section 1. General

KSYSA shall be divided into districts as determined by the Board of Directors Each district shall consist of its District Commissioner, Alternate District Commissioner and delegates of the district membership who are the voting membership of that district.

## Section 2. Election of District Commissioners \& Alternate District

## Commissioners

The district voting membership shall:
A. Prior to the Annual General Meeting, the district shall meet to elect a District Commissioner and Alternate District Commissioner.
B. The District Commissioner and Alternate District Commissioner shall assume office at the conclusion of the Annual General Meeting following their election.
C. If a district commissioner is not elected during the district meeting held immediately prior to the Annual General Meeting, the voting members in attendance at the Annual General Meeting shall elect an at-large board member to fill the vacancy as prescribed in Article V, Section 3.

## Section 7. Voting Rights in District

A. Each league or association shall be represented within the district by the number of voting delegates or votes as authorized in Article VIII, Section2.
B. District Commissioners shall have no vote except in the case of a tie.
C. Districts shall provide for representation of all teams domiciled in Kansas even though they may have received permission to play in another National State Association.

## Article VIII Annual General Meeting

## Section 1. Annual General Meeting

The annual general meeting shall be held in the first quarter of the calendar year. Notification will be given in writing to all members not more than sixty (60) nor less than thirty days before the meeting.

## Section 2. Voting Membership

A. The legislative and judicial powers of KSYSA shall be vested in the voting membership. The voting membership shall consist of duly elected or appointed representatives from each member organization. Individual Members shall enjoy voting rights only through their association with League Members.
B. The voting membership shall have the power to ratify, alter or reject decisions and policies of the Board of Directors.
C. The voting membership shall elect the officers of this association, make changes in the constitution and bylaws, and approve the annual budget.

## Section 3. Member Voting Rights

A. Voting strength for a seasonal year will be based on paid player registrations of the member as of July 31 each year prior to the start of the Annual General Meeting
B. The following formula shall be used to determine the number of votes that each member, in good standing, shall be entitled to cast at the Annual General Meeting

C. In all matters properly presented to the voting membership, each delegate shall have the right to cast one vote or cast all votes to which that organization is entitled if delegates are absent, but that delegate may NOT cast votes for any other member organization or individual at the same meeting. In no case shall the total number of votes cast be more than the number to which that member is entitled.
D. A delegate is defined as a duly elected or appointed representative from a specific member organization. If the voting delegate(s) of a member organization is anyone other than the President of that organization, he/she MUST present a signed and notarized letter from the President of their organization, including the name of the Member Organization and verification that the delegate carrying the vote(s) is a bona fide member of said member organization.
E. Proxy voting shall NOT be allowed at any KSYSA meeting.

## Section 4. Board of Directors Voting at Annual General Meeting

Each voting member of the KSYSA Board of Directors shall have one (1) vote at all meetings of the general membership (Annual General Meeting or Special General Meeting).

## Section 6. Quorum.

The quorum at the Annual General Meeting or Special General Meeting shall be onethird ( $1 / 3$ ) of the members entitled to vote.

## Executive Director Report - Joe Burger

Kansas Youth Soccer Board of Directors and District Commissioners:
During the past year, we have continued to strengthen/position Kanas Youth Soccer as a leader in USYS and US Soccer, while continuing to improve the relationships and communication between the state organization and our member organizations, referees, players, and parents.
App Development Continues - It has been beta tested at both the ODP Winter Friendlies and ODP Interregional
We continue to work hard to improve participation in State Tournaments and USYS National League.

- Kansas Participation is up in National League (E64/E64RL/Nation League Midwest Conference/)
- 2021/22 - + $144 \%$
- 2022/23 - + 68\%
- 2023/24-+46\%
- Kansas produced 1 USYS National Champion in 2023/24

As we continue to grow and improve opportunities that support our members. Sarah McTighe (Director of Membership \& Events) and Gillian Boehmer (Coordinator of Marketing \& Events) have created an atmosphere of professionalism in our office.

We have also added a TOPSoccer Coordinator, Mallorie LaFarge, that has already grown the program by adding a program in Wichita which will launch in late March, and she is in talks with two clubs in Kansas City to create new programs. Mallorie is also working to secure grants and solidify relationships with professional organizations within the state.
In the past year we have:

- Baker University - Piloted Educational Pathway that includes US Soccer Coaching Licensing
- Had one of the most successful National Championship Presidents Cup in Wichita \& Look forward to hosting again in 2024. Wichita has put in a five-year bid for hosting 2025 through 2029.
- Will be hosting USYS NCS Regional Championships for 2024 \& 2025 - Scheels \& Garmin Complex
- Final Site Visit to come in late April / early March (Olathe CVB leading)
- Partnered with Soccer Profile to help with supplemental education for coaches and players.
- Continue to work to improve sideline behavior with the "Creating Community" email campaign.
- We are strengthening the relationship between KSYSA and the State Referee Committee by working to look at the relationship as a partnership and involving them more in the overall soccer community.

All this would not be possible without the hard work and determination of our dedicated staff and Board of Directors.

## Director of Coaching - Paul Fabry

Overall, a great year on the technical side as we were able to provide more coaching courses and licenses across the state than we have in the past, while numbers stay high for ODP Programming and hosted events. We again had multiple players earn their selection to represent Kansas at the Midwest Regional and US Youth Soccer National team levels. We continue to provide pathways for ODP players to take advantage of opportunities to perform in front of US Soccer Scouts, MLS Scouts, and College Coaches. We look forward to more coaching education and licensing in the coming year to help push the game in a developmentally appropriate fashion to help all coaches and players enhance the game.

- Tryouts at three locations- Kansas City, Dodge City and Wichita, with top players from all three locations called back for round 2 of tryouts against other top players. Select a pool of 25-32 players in each age group for State Pool in each age group. Events attended as ODP teams formed with limited to rosters of the top 16-18 players for each age group that have earned the invite to events through level of performance.
- Second year of splitting youngest age group, 2012, into half birthyear (Jan-June and JulyDec) to help with development at younger age groups and combat the "relative age effect" during selection and training over the course of the year. This showed great success from last year by increasing player pool for the 2011 age group at 2023-24 tryouts as more players were able to contribute in previous cycle in appropriate fashion.
- Added games against colleges for oldest age group on girls' and boys' sides to give experience of recruiting process, campus visits, and exposure to college coaches through program. Also added referee evaluation during these for those looking to be evaluated for college games through this.
- Continue to expand and enhance staffing across state.

ESPN and Aspen Institute recently teamed up for the "Don't Retire, Kid" campaign based on the content of a study by Aspen Institute and the Utah State University Families in Sports Lab that shows most kids quit organized sports by age 11. The number of kids playing sports is decreasing and soccer has taken the biggest hit among team sports, with the number of children playing the game on a regular basis down by $18 \%$ in the last 5 years.

Of the MANY important factors for kids dropping out or not participating in sports, we must address the lack of enjoyment and the increased pressure to win. THE NUMBER 1 REASON KIDS SAY THEY LIKE PLAYING SPORTS IS TO HAVE FUN.

The pressure placed on these kids at a young age is one of the key factors for them dropping out. In the US failure, errors, losses, and mistakes are interpreted as negative and that is unfair and unnecessary for young developing minds. We believe our young players have to continually make mistakes, lose some games, and fail sometimes so that they can learn and improve. Each failure or mistake is an opportunity to get better. Oftentimes the pressure of winning or being seen for the next step - professional or college - is forced on them too young, making the process a lot less fun. Above all, B-Elite wants to create a safe place where kids can make mistakes and improve every day.

What kids need is proper instruction, competition, constructive feedback, and positive reinforcement. Although we always try to win, winning is secondary. Individual success does not depend on winning. If young players have the talent, they will be "seen."

Realistically, most kids will not reach a professional level, and many will not even play competitively in college, so the most important thing is for our kids to give it their all, reach their potential, become well-rounded players, and most importantly productive members of society. We must teach them life lessons through sport and continue encouraging a passion for soccer so that they can apply skills like teamwork, responsibility, hard work, resilience, fitness, leadership, etc. throughout the rest of their lives. This fundamental part of youth sports is oftentimes lost in present-day youth soccer and leads to unhappiness in our youth. The indirect implications on our youth for losing sight of the "fun" are critical increased depression and obesity to name a few.

## Annual Treasurer Report

The KSYSA 2023 financial report, which can be found in the Appendix section of the AGM Booklet, pertains to the August 31, 2023, fiscal year-end reports, along with the previous year for comparison analysis. The annual tax returns for the fiscal year ending 08/31/2023 will be prepared by the accounting firm of Bellwether Tax \& Accounting.

KSYSA remains in a "good" financial position. KSYSA achieved a "Total Income" \$1,050,589, which was $\$ 14,000$ below the previous year. Total Expenses exceeded the prior year by 24,000 , thus reflecting KSYSA with a Net Loss of $\$ 23,305$. Some of the increased expenses were resulted from increased field rental expense, insurance expense, referee expense and salaries and wage increases. Our Director of Referee, which was hired in mid-April 2022, thus reflected a full year of expense compared to five months for the previous year. I have no concerns of this "Good" financial status changing in the near future.

We are continuing to utilize the funds for providing mentoring and educating to our referees. This continues to provide opportunities for recruiting and mentoring our state referees, as they continue to be an important part of the success of our soccer community.

I have continued enforcing "controls" to reduce any risk of fraudulent activities for KSYSA. These "controls" include the following:
o Converted to a cloud-based platform for our accounting software, for security and backup compliance.

- Check Writing, Online Banking Transfers, and Signature control.
- Utilization of a third-party bookkeeping service
o Restricting all employees access to payroll, and using a reputable third-party payroll system
- Annual Performance Reviews of KSYSA employees prepared by Executive Director and reviewed by Executive Board Members
- Mandating Government Compliance of Employees and Contractors providing Service to KSYSA
o Mandating Background Checks on all individuals employed or contracted with KSYSA.
o Monthly reviews and reconciliations
o Restricting Employed staff access from making changes to the KSYSA Accounting information
o Providing detail reports and reconciliations to the Executive Board members
- Providing detail reports to the Executive Director

## State Youth Referee Administrator Gordie Wetmore

We had a successful year in the Kansas Soccer Referee Development Program in many areas. The representation and success of our officials at the regional and national levels is very exciting, hopefully providing inspiration and knowledge of the path forward for officials of all ages and skill levels across the state. We continue to leverage technology to connect and grow a geographically spread community from recruiting and development perspectives. Our biggest challenge continues to be retention even more so than recruitment, so we need an entire Kansas soccer community to embrace plans for a more positive game day experience for all participants, officials included.

Without dwelling too much on the negative, I want to clearly outline the largest challenges facing the referee community in Kansas before providing status updates on events and ongoing projects. Below are our areas of growth both as a referee community and broadly as the Kansas soccer community:

- Creating a Positive Gameday Atmosphere. Our retention issues largely reflect the inability for new referees to have space to grow and learn. These officials, many of whom range in age from 12-17, are expected to step on the field as experts in both the Laws of the Game and their correct interpretation, as well as be professional people managers and communicators. When these individuals inevitably fall short of such demands, there is little to no grace given for these errors. In fact, verbal and emotional abuse tends to be a common reaction from spectators especially at 7 v 7 and 9 v 9 matches. Kansas referees need a community that embraces them, helping them grow and develop just like we strive to do for our athletes and coaches.
- Recruiting the Right New Officials. We don't just need warm bodies (although it feels like that some weekends), we need the right warm bodies. In other words, we need individuals who...
- Know and like soccer.
- Are somewhat physically prepared for the demands of the job.
- Have the social skills to look someone in the eye and have a conversation.
- Can be coachable/willing to grow and learn.
- Continuing Education and Support. As the players and coaches improve, we must make sure that our referees are getting better as well. The challenge is twofold; incentivizing continuing education and then providing quality content in well put together learning opportunities. Mentoring accomplishes both the continuing education piece all with field-side support and continues to be a top priority for the KRDP. We are incredibly grateful for Kansas Youth Soccer's commitment to financially support referee mentoring efforts across the state.
- Local League/Tournament Assigning. Putting the wrong referees on the wrong games impacts the entire ecosystem. Local youth league referee leadership (assignors, directors of development,
mentoring coordinators, field marshals, etc) must establish relationships with their referees to understand their individual needs and pair them with the needs of the league/tournament. While time consuming, this kind of individualized attention will be the most beneficial for the referee as well as the league/event/tournament.

## I.PROPOSED AMENDMENT

## III. RATIONALE

Clubs from both KSYSA and MYSA both participate in Heartland Soccer League, but the maximum roster size is not equal for both states. Clubs in Kansas are only allowed to roster 12 players (while Missouri clubs can roster 14). For clubs from Kansas to increase their game day rosters while participating in Heartland league, clubs must fill out guest player paperwork weekly. This can be eliminated and decrease workloads for clubs by affording Kansas clubs a maximum roster of 14 players for 7 v 7 age groups. This minor rule change streamlines both state associations maximum roster policies and deletes the need for weekly paperwork for clubs to submit.
